All parts appertaining to the stationary installed photovoltaic systems (as well as associated parts and infrastructure installation), containing in particular of the following individual components: solar modules, collectors, switch gear, control and monitoring systems, transformers, overvoltage protective devices (lightening arrestors), cabling and underground cabling, own buildings and housing elements for inverters, fences, connecting and fixing materials, foundations and support structures.

All Risks:

The Insurer shall indemnify for any unforeseen damage to, or destruction of insured property (property damage), or loss of insured property caused by theft, burglary, robbery or looting.

Consequential Loss:

If the technical application of an item specified in the insurance policy is discontinued or impaired due to the occurrence of an insured event at the insurance location, the Insurer shall indemnify for the consequential loss.

Revenue shortfall insurance:

If the annual energy productivity of the insured photovoltaic plant, as forecasted by an expert energy assessment, declines by more than 10 %, the Insurer shall compensate for the re-

sultant revenue shortfall.
